- 5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Odisha Education Act-1969 as amended from time to time.
- The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.
- 7. The land on which the school stands is recorded in the name of the Trust / Society / Agency which manages the School. It will be the responsibility of the School Authority to record the required land (1.00 Ac in Urban / 1.50 Ac. in Rural) in the name of the school and submit copy of the RoR to this Directorate within one year for continuance of NOC
